# Modern Terrorism and Counter-Strategies: Addressing Governance Vulnerabilities and Technological Exploitation in Nigeria

#### ABSTRACT

This study examines the evolving dynamics of terrorism and assesses modern counter-terrorism strategies to address increasingly complex global security challenges. Focusing on developments since 2022, it highlights the emergence of cyber-terrorism, the strategic use of social media for recruitment and propaganda, and the growing decentralization of terrorist operations. Using a qualitative methodology, the research synthesizes insights from academic sources, government documents, and think tank reports to identify trends, evaluate current strategies, and pinpoint gaps. The findings reveal that terrorist groups exploit advanced technologies and governance vulnerabilities to enhance their influence and resilience. Key trends include cyber-attacks and decentralized structures, which challenge traditional counter-terrorism approaches. Progress has been made through initiatives like international cooperation and community engagement, but these efforts are often hindered by geopolitical tensions and resource limitations in fragile states. To address these challenges, the study advocates for a multidimensional strategy combining military, technological, and community-driven approaches. Recommendations include strengthening cybersecurity, expanding grassroots efforts to prevent radicalization, and fostering cohesive global collaboration. By leveraging emerging technologies and addressing systemic weaknesses such as terrorist "shadow governance,." this research underscores the urgency of adaptive and holistic strategies to counter contemporary terrorism effectively.

#### INTRODUCTION

In the current national security environment across the global world, there is little question that terrorism is among the gravest of threats (Burom 2004). Massive resources throughout the government and private sectors have been allocated and re-allocated to the task of preventing terrorism (Horgan & Taylor, 2001; Horgan, 2003; Borum, Fein, Vossekuil & Gelles, 2003; Burom, 2004). Today, terrorism has remained a pressing global security challenge, continuously evolving as terrorist organizations adopt new tactics and technologies to out manoeuvre traditional count-

er-terrorism measures. Since the post-9/11 era, the nature of terrorism has undergone significant shifts—from centralized, large-scale operations to decentralized networks employing asymmetric warfare, cyber-terrorism, and social media for recruitment and propaganda. These changes have been shaped by geopolitical developments, technological advancements, and shifts in ideological drivers. Regions worldwide, from the Middle East and Africa to Europe, Asia, and North America, continue to grapple with the far-reaching impacts of terrorism. The proliferation of extremist ideologies and the rise of transnational terrorist groups like ISIS, Al-Qaeda, Boko Haram, and their splinter factions have redefined global security priorities. Additionally, the surge in lone-wolf attacks, domestic terrorism, and cyber-enabled threats has added complexity to the challenges faced by law enforcement and security agencies. As terrorist organizations adapt to contemporary socio-political and technological landscapes, understanding their evolving strategies is essential.

Psychology, as a discipline, has a long history of (perhaps even a bias toward) looking first to explain violent, deviant behaviours and other form of dysfunctional behaviours as a function of psychopathology (i.e., mental disease, disorder, or dysfunction) or maladjusted personality syndromes. As Schmid and Jongman (1988) noted, "The chief assumption underlying many psychological 'theories'...is that the terrorist in one way or the other not normal and that the insights from psychology and psychiatry are adequate keys to understanding." In reality, psychopathology has proven to be, at best, only a modest risk factor for general violence, and all but irrelevant to understanding terrorism. In fact, "the idea of terrorism as the product of mental disorder or psychopathy has been discredited." (Crenshaw, 1992). While early research seemed to focus almost exclusively in some way on "why" individuals become terrorists or engage in terrorism, the research questions in this realm, informed by a degree of experience, became more focused and more functional (Borum, Swartz & Swanson, 1996; Horgan & Taylor, 2001; Borum, Fein, Vossekuil & Gelles, 2003; Burom, 2004). Implicit in the "why." question was an assumption that becoming a terrorist involved a discrete choice to change status (Horgan & Taylor, 2001). Social and operational observations of numerous terrorist and extremist groups, however, suggest that recruitment and involvement typically do not occur in that way.

Indeed, as Horgan and Taylor (2001) have noted: "What we know of actual terrorists suggests that there is rarely a conscious decision made to become a terrorist. Most involvement in terrorism results from gradual exposure and socialization towards extreme behavior." Seeking a better framework within which to examine the question of "why an individual becomes a terrorist." Crenshaw, for example, suggested that the issue of "why terrorists persist despite the risks involved and the uncertainty of reward is an important question." (Crenshaw, 1986). Moreover, she notes that there is a high rate of attrition in terrorist organizations, which itself begs for a greater understanding of how and why some exit or leave terrorist organizations or even desist from terrorist behavior. Psychologists John Horgan and Max Taylor have structured the issues in a most perspicuous way for terrorism researchers by drawing on contributions from theoretical and developmental criminology "to consider involvement in terrorism as a process comprised of discrete phases to becom-

ing' a terrorist, 'being' a terrorist (or what might be construed as both a) remaining involved and b) engaging in terrorist offences) and disengaging from terrorism." (Horgan, 2003; Burom, 2004). They suggest that "a fundamental distinction can be made then in analyzing the factors at work at the different stages of becoming, remaining, and leaving or terminating involvement" (see, Borum, Swartz & Swanson, 1996; Borum, Fein, Vossekuil & Gelles, 2003). Thus, this paper examines emerging trends in terrorism from 2022 onward, evaluates the changing nature of these threats, and explores innovative approaches to counter-terrorism. By contributing to the ongoing discourse on global security, this research underscores the urgency of adaptive, multifaceted strategies to address the dynamic challenges posed by modern terrorism

The emergence of asymmetric warfare, cyber-terrorism, and the strategic use of social media for recruitment and propaganda has fundamentally transformed the terrorism landscape. Unlike traditional conflicts, where military force could effectively neutralize threats, modern terrorism thrives on decentralization, unpredictability, and the exploitation of societal and technological vulnerabilities. The convergence of physical and digital domains has created significant challenges in detecting, preventing, and countering terrorist activities. The internet has facilitated the global spread of extremist ideologies, enabling terrorist organizations to recruit followers and disseminate propaganda across borders with minimal effort and resources. Social media platforms, encrypted communication tools, and the dark web have become critical enablers for radicalization, operational planning, and the execution of attacks, further complicating counter-terrorism efforts.

Despite advancements in counter-terrorism measures, significant gaps persist in addressing these evolving threats. These include inadequate coordination among international security agencies, insufficient community-based interventions, and delays in adopting advanced technologies to combat cyber-terrorism. This study aims to bridge these gaps by examining current trends, assessing the effectiveness of existing strategies, and providing actionable recommendations for more robust counter-terrorism approaches. The following are the objectives of the study:

- Analyze the evolving nature of terrorism and its implications for global security.
   By examining recent trends in terrorism, this study will identify how terrorist organizations are adapting their strategies and the implications for international security.
- Evaluate current counter-terrorism strategies and their effectiveness in combating modern threats.
   A thorough assessment of contemporary counter-terrorism strategies will be conducted to determine their strengths, weaknesses, and areas for improvement.
- 3. Identify significant gaps in the literature related to counter-terrorism.
  This study aims to highlight the deficiencies in current academic and policy-oriented literature concerning counter-terrorism, particularly in addressing emerging threats.
- 4. Propose recommendations for improving counter-terrorism efforts.

Based on the findings, the study will offer practical and innovative recommendations to enhance counter-terrorism strategies at both national and international levels.

#### THEORETICAL PERSPECTIVES ON TERRORISM

Terrorism is a complex, multifaceted phenomenon that resists simplistic explanations, requiring a robust theoretical framework to unpack its motivations, origins, and methods. Scholars have examined terrorism through various lenses, including psychological theories, political theory, social identity theory, and globalization theory, each offering unique insights into the drivers of terrorism and strategies for counteracting its spread.

The instinct theories: Hitherto known as psychoanalytic theory and ethology: Psychoanalytic theory is "The most widely recognized theory that addresses the roots of all forms of violence is the psychoanalytic model. Despite its influence on writers in the political science, sociology, history, and criminology literature, this model has weak logical, theoretical, and empirical foundations." (Beck, 2002). Freud viewed aggression more generally as an innate and instinctual human trait, which most should outgrow in the normal course of human development. A later development in Freud's theory was that humans had the energy of life force (*eros*) and death force (*thanatos*) that sought internal balance. Violence was seen as the "displacement." of thanatos from self and onto others. A number of more narrow violence-related theories have drawn on psychoanalytic concepts and ideas, but none are widely regarded as psychoanalytic theories of violence. Ethology: (i.e. The scientific study of animal behaviour). Ethologist, Konrad Lorenz advanced the notion that aggression arises from a very basic biological need—a "fighting instinct." that has had adaptive value as humans have evolved. He argued the drive from aggression is innate and that, in humans, only its mode of expression is learned through exposure to, and interaction with the environment (Burom, 2004). The theory of an instinctual drive for aggression suggests that it builds up over time, is fueled by emotional or psychophysiological arousal, and is subsequently discharged by a process of catharsis, which ostensibly decreases drive.

Frustration-aggression theory: When people perceive that they are being prevented from achieving a goal, their frustration is likely to turn to aggression. The link between frustration (being prevented from attaining a goal or engaging in behavior) and aggression has been discussed in psychology for more than half a century. Some even view it as a "master explanation." for understanding the cause of human violence (Borum, Fein, Vossekuil & Gelles, 2003; Burom, 2004). The basic premise of the frustration-aggression hypothesis is twofold: (1) Aggression is always produced by frustration, and (2) Frustration always produces aggression. When subjected to empirical scrutiny, however, research has shown that frustration does not inevitably lead to aggression. Sometimes, for example, it results in problem solving or dependent behaviors. And aggression is known to occur even in the absence of frustration. Thus it is not reasonable to view frustration alone as a necessary and sufficient causal factor. Frustration-Aggression Theory, proposed by Dollard et al. (1939) is very prominent, it suggests that individuals resort to violence when they are unable to achieve

their goals, often as a result of socio-political obstacles. Terrorism, in this context, is a reaction to unmet socio-political demands or grievances. The frustration aggression theory states that aggression is caused by frustration (Dollard, Miller et al., 1939; Berkowitz, Leonard, 1969). When someone is prevented from reaching his target, he becomes frustrated. This frustration then can turn into aggression when something triggers it. The closer you get to a goal, the greater the excitement and expectation of the pleasure. Thus the closer you are, the more frustrated you get by being held back. Unexpected occurrence of the frustration also increases the likelihood of aggression Dollard, Miller et al., 1939; Berkowitz, Leonard, 1969). In an important reformulation of the FA hypothesis, Berkowitz (1989) posited that it was only "aversive." frustration that would lead to aggression. The newly proposed progression was that frustration would lead to anger, and that anger – in the presence of aggressive cues – would lead to aggression. While subsequent research findings have, at times, been inconsistent or contradictory, "it is reasonable to conclude that aversive stimuli do facilitate, but probably not instigate, aggressive behaviour" (Borum, Swartz & Swanson, 1996; Tedeschi & Felson, 1994, p. 688). In a now classic work, Ted Gurr was among the first to apply a systematic FA analysis to the problem of political violence, framing the frustration as one of "relative deprivation." (Gurr, 1968).

Social learning theory: Fundamental learning theory suggests that behavioral patterns are acquired by links (contingencies) established between the behaviour and its consequences. When behaviour is followed by desired results (reward), that behaviour is "reinforced" (made more likely). Conversely, when behaviour is followed by undesirable or aversive consequence, that behavior is "punished" (made less likely). Social learning theory is a simple extension of this basic idea, suggesting that behavior (e.g., aggression) is learned not only through one's direct experience, but also through observation of how such contingencies occur in one's environment. Some have referred to this as vicarious learning. In this model, aggression is viewed as learned behavior. Accordingly, it is argued that through observation we learn consequences for the behavior, how to do it, to whom it should be directed, what provocation justifies it, and when it is appropriate. "If aggression is a learned behaviour, then terrorism, a specific type of aggressive behaviour, can also be learned." (Oots & Wiegele, 1985, p. 1110; Borum, Swartz & Swanson, 1996; Oots, 1989)

Political theory: Political theory views terrorism as a calculated strategy employed by non-state actors to pursue political, social, or ideological objectives, particularly in contexts where conventional political channels are perceived as ineffective or inaccessible. This perspective highlights the role of political grievances, state repression, and socio-economic disparities in fostering radicalization and violent action. Crenshaw (2022) asserts that terrorism often emerges when individuals or groups feel politically marginalized, oppressed, or disenfranchised. When peaceful political activism fails or is met with severe repression, terrorism may become a means of drawing attention to grievances and pressuring authorities to meet demands. For instance, separatist movements in politically repressive regions have historically turned to terrorism to seek autonomy or independence. Socio-economic inequalities also play a critical role, creating conditions ripe for radicaliza-

tion. Populations excluded from political participation or economic prosperity may see terrorism as a means to challenge entrenched systems of power. This dynamic is especially evident in conflict zones where poverty, lack of education, and limited political representation intersect, providing fertile ground for terrorist recruitment. Counter-terrorism strategies informed by political theory emphasize addressing underlying causes, such as political grievances and socio-economic inequalities. Key approaches include political reforms, fostering inclusive governance, engaging marginalized communities in dialogue, and implementing socio-economic development initiatives. For example, in Northern Ireland, peace negotiations and the political integration of groups with militant histories significantly contributed to de-escalating violence. These strategies highlight the importance of tackling root causes to reduce the appeal of terrorist ideologies.

Social identity theory: Social identity theory, developed by social psychologists, explores how individuals derive their sense of identity, belonging, and purpose from group affiliations. This framework has been instrumental in understanding radicalization processes and the role of identity-based conflicts in fueling terrorism. Tilly and Wood (2023) suggest that radicalization often stems from group dynamics, where individuals develop a strong allegiance to their in-group while perceiving out-groups as threats. This "us versus them." mindset can escalate into violence, particularly when group identity becomes politicized or is perceived as being under attack. Extremist groups exploit these dynamics by promoting narratives of victimization and offering a collective identity that provides purpose, respect, and a sense of action against perceived oppressors. When individuals feel that their cultural, religious, or ethnic identity is marginalized or threatened, they may gravitate toward radical ideologies as a form of defense. This phenomenon is evident in contexts such as the radicalization of diaspora communities, where individuals often experience disconnection from both their home and host societies. Extremist propaganda leverages these feelings of alienation, employing identity-based rhetoric to recruit and radicalize individuals. Counter-terrorism strategies based on Social Identity Theory emphasize fostering social cohesion, reducing identity-based discrimination, and dismantling divisive narratives. Initiatives such as community engagement programs, interfaith dialogues, and efforts to build inclusive national identities have shown promise in preventing radicalization. Additionally, counter-narratives that directly challenge extremist rhetoric on social media play a critical role in reducing the appeal of radical ideologies. For example, grassroots campaigns in European countries have successfully promoted messages of inclusion and tolerance, diminishing the influence of extremist groups on marginalized youth.

Globalization theory: Globalization theory frames terrorism as a consequence of the increasing interconnectedness of the modern world. It explores how globalization facilitates the rapid exchange of ideas, technologies, and resources that simultaneously empower terrorist organizations and bolster global counter-terrorism efforts. Sageman (2022) argues that globalization has enabled terrorist groups to operate across borders, utilizing modern communication technologies, global financial systems, and transportation networks to coordinate attacks on an international scale. The

internet, in particular, has become a critical tool for disseminating extremist propaganda, recruiting members, and orchestrating operations. The phenomenon of "lone wolf." attackers radicalized online highlights how globalization can spread terrorist ideologies without the need for direct organizational involvement.

While globalization has extended the reach of terrorist networks, it has also enhanced counter-terrorism capabilities. Advances in international cooperation, intelligence sharing, and technological innovation—especially in surveillance and cybersecurity—have strengthened the ability to detect and thwart terrorist activities. Institutions such as INTERPOL and initiatives like the Global Counter-Terrorism Forum (GCTF) exemplify the collaborative efforts to address terrorism on a global scale. Globalization Theory emphasizes the importance of international cooperation and technological advancement in counter-terrorism strategies. Key measures include monitoring transnational financial transactions, improving border security, and combating online radicalization. Additionally, addressing the socio-economic effects of globalization, such as economic inequalities and cultural alienation, can reduce the conditions that foster radicalization. Cybersecurity initiatives, international treaties, and multilateral organizations are crucial in this fight. The European Union's counter-terrorism framework, which emphasizes shared intelligence and joint operations, serves as a successful example of regional collaboration to enhance security.

Theoretical Integration and Empirical Insights

Political theory, social identity theory, and globalization theory each offer valuable perspectives on the multifaceted nature of terrorism. Political grievances, identity-based dynamics, and the impact of globalization are all critical in understanding the roots and mechanisms of terrorism. Combining these theoretical frameworks allows for a more holistic approach to counter-terrorism, addressing immediate threats while targeting the underlying socio-political factors that enable terrorism to thrive. By incorporating political reform, fostering social cohesion, and enhancing global cooperation, this integrated approach strengthens both national and international security efforts.

Awan and Rehman (2023) emphasize the importance of community-based initiatives in preventing radicalization, noting that fostering trust and grassroots collaboration in the UK significantly reduced extremist influence. Similar successes have been observed in Southeast Asia, particularly in Indonesia and Malaysia, where post-COVID counter-radicalization efforts have thrived due to sustained government-community cooperation, effectively curbing terror recruitment and activities. Zhang and Patel (2023) highlight the growing threat of cyber-terrorism, emphasizing the increasing sophistication of cyber-attacks targeting critical infrastructure. Decentralized terrorist networks increasingly leverage cyberspace for recruitment and operational coordination, making enhanced international cybersecurity cooperation and multi-stakeholder partnerships essential in addressing this evolving challenge. Hafez and Mullins (2022) examine the dual role of social media in spreading extremist ideologies and countering them through counter-narratives. Their findings indicate that coordinated campaigns involving both governmental and non-governmental actors

are critical to effectively challenging extremist rhetoric. These efforts have been particularly vital in combating the online influence of groups like ISIS and al-Qaeda, which remain active in cyber-space despite territorial defeats.

Kinsella and Wright (2023) underscore the importance of international cooperation in intelligence sharing and joint military operations. However, they note that geopolitical tensions and trust deficits often hinder such collaboration. In regions like the Sahel and Central Asia, joint efforts have achieved mixed results. While cooperative military operations have weakened groups like ISIS Central Africa, challenges related to political instability and weak governance continue to undermine sustainable outcomes. Recent assessments reveal that terrorist organizations such as ISIS and al-Qaeda affiliates have adapted by exploiting weak governance in regions like West Africa and the Sahel. These groups engage in "shadow governance,." filling administrative gaps in fragile states and complicating traditional military-based counter-terrorism strategies. Additionally, Iran's state-sponsored terrorism, exemplified by its support for groups like Hezbollah and Hamas, highlights the geopolitical complexity of counter-terrorism. Such support includes extensive financial and logistical backing, further complicating global counter-terrorism efforts in the Middle East and necessitating nuanced diplomatic and military responses.

#### **METHOD**

Design: This research employs a qualitative approach, synthesizing existing literature from academic journals, government reports, and think tank publications. A systematic review of articles published from 2022 to the present was conducted, focusing on contemporary theories and empirical findings relevant to counter-terrorism.

Results: To identify the relevant social science literatures, we began by searching a series of major academic databases using a systematic, iterative keyword strategy, mapping, where possible onto existing subject headings. The focus was on locating professional social science literature published in some selected major books and frontline peer-reviewed journals. The following database searches were conducted in December 2024: Sociofile/Sociological Abstracts, Criminal Justice Abstracts (CJ Abstracts), Criminal Justice Periodical Index (CJPI), National Criminal Justice Reference Service Abstracts (NCJRS), PsychInfo, Medline, Public Affairs Information Service (PAIS) and APA Abstracts. The "hit count." from those searches is summarized in the Table 1. After the initial list was generated, we cross-checked the citations against the reference list of several major review works that had been published in the preceding three years. Finally, the list was submitted to the three senior academic consultants soliciting recommendations based only on relevance.

#### SUMMARY OF FINDINGS FROM LITERATURES

- Objective 1: Analyze the evolving nature of terrorism and its implications for global security—The findings reveal an increased reliance on technology by terrorist organizations, particularly in cyber-terrorism and the strategic use of social media for recruitment and propaganda (Zhang & Patel, 2023; Hafez & Mullins, 2022). These advancements support decentralized operations and broaden the global influence of extremist ideologies. The rise of decentralized structures, such as ISIS affiliates in Africa and Central Asia, highlights the ability of these groups to exploit weak governance and societal vulnerabilities. These dynamics introduce new risks to global security, requiring innovative strategies that address immediate threats while targeting systemic drivers of terrorism.
- Objective 2: Evaluate current counter-terrorism strategies and their effectiveness in combating
  modern threats—Contemporary counter-terrorism approaches incorporate international cooperation and advancements in cybersecurity. However, their effectiveness is constrained by
  geopolitical tensions and resource disparities, particularly in fragile regions such as the Sahel.
  Community engagement initiatives have proven effective in curbing radicalization and fostering resilience, as seen in successful programs in the UK and Southeast Asia (Awan & Rehman,
  2023; RSIS, 2023).
- Objective 3: Identify significant gaps in the literature related to counter-terrorism—The research identifies a lack of integrated frameworks that address the interaction between globalized technology and localized governance weaknesses. Specifically, there is insufficient focus on countering "shadow governance." by terrorist organizations in regions with limited state control. Additionally, the literature inadequately explores the integration of emerging technologies into counter-narrative strategies to effectively preempt extremist content online.
- Objective 4: Propose recommendations for improving counter-terrorism efforts—The findings underscore the importance of a multi-faceted approach that combines military, technological,

and community-based strategies to address the evolving threat landscape. Enhanced international cooperation, advanced cybersecurity initiatives, and grassroots engagement are essential for countering the complex dynamics of modern terrorism.

The findings align closely with the study's objectives, highlighting the dynamic evolution of terrorism and the urgent need for adaptive, holistic counter-terrorism measures. By addressing identified gaps and leveraging innovative solutions, global security frameworks can more effectively mitigate the multifaceted threats posed by modern terrorism.

#### DISCUSSION

The study's findings provide a detailed and evolving perspective on modern terrorism and the counter-terrorism strategies aimed at addressing it. Today's terrorism is increasingly defined by its use of technology, decentralized structures, and the exploitation of systemic vulnerabilities. As noted by Zhang & Patel (2023) and Hafez & Mullins (2022), digital tools and platforms—such as cyber-attacks and social media—are now central to terrorist tactics. These platforms facilitate recruitment, the spread of propaganda, and operational coordination, enabling groups to extend their influence beyond their local territories. The adaptability of organizations like ISIS, especially through their affiliates in Africa and Central Asia, illustrates how decentralized groups exploit weak governance, intensifying global security risks.

In terms of counter-terrorism effectiveness, the study highlights key progress, particularly through increased international cooperation and bolstered cybersecurity measures. Kinsella & Wright (2023) stress that intelligence sharing and joint operations are critical to global counter-terrorism success, although geopolitical conflicts often impede their full potential. Awan & Rehman (2023) also examine community engagement initiatives, which have shown promising results in reducing radicalization and promoting local resilience. These efforts, particularly in the UK and Southeast Asia, emphasize the value of involving local populations in broader security measures to effectively counter extremist ideologies.

Despite these improvements, significant gaps remain in both counter-terrorism theory and practice. The relationship between globalization, technology, and local governance has not been sufficiently explored, as evidenced by the lack of comprehensive frameworks to address these interconnected issues. The phenomenon of "shadow governance," where terrorist groups take over administrative functions in areas with weak state control, complicates efforts to neutralize these threats. Additionally, current counter-narrative strategies are not adequately integrated with emerging technologies, reducing their effectiveness against the widespread influence of extremist content online.

The study underscores the need for multi-dimensional counter-terrorism approaches that incorporate military, technological, and community-driven strategies. It is critical to move beyond

reactive measures and tackle the systemic conditions that allow terrorism to flourish. This involves fostering trust in international partnerships, enhancing the technological capabilities of counter-terrorism efforts, and strengthening community resistance to radical ideologies.

Overall, the findings align closely with the study's goals, providing a comprehensive understanding of the evolving dynamics between terrorism and counter-terrorism. They also highlight the urgent need for adaptable, innovative, and coordinated global responses. By addressing the identified gaps and capitalizing on emerging opportunities, such as advancements in artificial intelligence and deeper international cooperation, the global community can more effectively anticipate and address the complex threats posed by modern terrorism.

#### CONCLUSION

In conclusion, terrorism remains a dynamic threat requiring urgent and innovative countermeasures. The interplay between technological advancements, social dynamics, and global cooperation will define the future of counter-terrorism strategies. Effective counter-terrorism must not only address immediate threats but also the underlying conditions that foster radicalization.

#### RECOMMENDATIONS

- 1. Governments should invest in community engagement programs to foster resilience against radicalization.
- Enhanced cybersecurity measures should be implemented to counteract potential cyberterrorism threats.
- 3. International collaboration must be prioritized, focusing on intelligence sharing and coordinated operations.
